- ✓ The scholarship panel has final discretionary rights for selecting the winners for the Scholarship. The scholarship panel decisions are final and binding on all.
- ✓ Reasons for not being awarded a scholarship will not be provided.
- ✓ The period of time the scholarship is offered for is clearly stated and not extendable.
- ✓ The scholarship is non-encashable & non-refundable.
- ✓ All scholarship students should be in good mental and physical health and must advise the scholarships office of any medical conditions they may have.
- ✓ Originals of transcripts and documents submitted along with the their scholarship application need to be presented to the, Scholarships office for verification. In case there is any discrepancy or misrepresentation, the application will be rejected and considered invalid. The Institute accepts NO liability in this case.
- ✓ It is the scholar's responsibility to set a good example, e.g. strive for best results, attend classes, finish the course on time and continue to demonstrate the exemplary student attributes/grades by which he/she was awarded the scholarship.
- ✓ All scholars should finish their course on time. Any lack on account of the scholar not been able to complete the course on time will lead to the termination of the scholarship and the student will become liable to pay the Institute the moneys that would have been payable to the Institute as if the scholarship was not awarded.
- ✓ The Institute has the right to display photographs of the Scholar in its various marketing initiatives and also take interviews and do all other acts as may be necessary to promote and propagate the Institutes education programs.
- ✓ We may feature your interview/photo/profile/story on ILAM's website and/or other Institutes publications.
- ✓ The Institute reserves the right to utilise this information in the promotion of the Institute and in any other student recruitment and/or Scholarship promotion activities.
- ✓ All scholars will take part in welcoming new scholars to the scholarship programme by attending scholarship evenings, etc. when invited.

- ✓ The Institute reserves the right to investigate and possibly withdraw a person from the scholarship programme, if there is adequate proven evidence of serious allegations of illegal activities discovered.
- ✓ The Institute reserves the right to make reasonable changes to this contract at any time and will advise valid scholars if this occurs, as and when required.
- ✓ The Scholarship is awarded only to Indian Nationality students.
- ✓ The Scholarship is awarded only on the Tuition fees and for students who complete the course in India specifically during the said course duration as specified by the Institutes application form. Exam fees and taxes if any have to be borne by the Scholar. Where the Scholarship is for a part amount, then the same would be adjusted against the Tuition fee payable and the scholar would have to pay the balance within the stipulated time.

### **Termination of the scholarship**

The scholarship can be terminated immediately amongst other reasons if the scholarship holder:

- a) Provides/provided wrong, false or incomplete information;
- b) Has disturbed order of the Institute and faces action in accordance to the policies laid down by the Institute.
- c) Fails to observe the Terms and Conditions of the Institute or refuses to act in accordance with oral or written instructions issued to them by Institute in connection with the scholarship;
- d) Falls short of the requirements of the study programme;
- e) Voluntarily withdraws from the programme, or is obliged to withdraw through his or her own fault;
- f) Changes his or her study programme without prior written consent of the Institute/Dean/Concern Authorities;
  - Terminates his or her registration as a student.
  - If the scholarship is terminated on the grounds mentioned in rules and regulations, the scholarship holder can be required to return any payments made by the Institute.
  - If the scholarship is terminated, its holder is not entitled to the remainder of the scholarship.
  - If the scholarship is terminated or expires, of these Terms and Conditions applies. Institute is not liable or responsible for the scholarship holder on expiry of the period mentioned by the Course Director/Head of Departments Terms and Conditions.
